A monthly safety meeting was held. Foreman Mathis outlined his job duties as foreman. Job assignments will be issued by Foreman Mathis. Monthly paperwork including time sheets will be turned in each month. Time sheets are required to be filed by the 27<sup>th</sup> of each month. All compensatory time accrued will have to be preapproved by Foreman Mathis. Work times and scheduling was discussed. Employees will work 7:00 a.m. to 3:00 p.m. if they do not take a lunch hour. Time off will be prearranged. Emergencies are the only variation to normal working hours. OSHA regulations regarding steel toed boots and hard hats were discussed. Blades will be down on machines when exiting them. The doors on equipment have to be closed or latched open. Safety glasses, face shields, reflective vests and fire extinguishers were discussed. Seat belts are to be worn by everyone. Use of county equipment at fires was also discussed. Employees are not required to run county equipment at a fire if they do not feel comfortable doing so. All employees were encouraged but not required to obtain a Class A CDL license.






