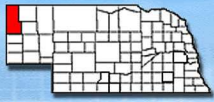

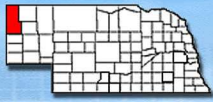
Sheriff McCumbers updated the board stating that his new pickup should be shipped by the end of the week. Training requirements for the sheriff's office staff are fully complete.

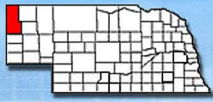

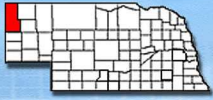
Correspondence was read from Nadine Baker concerning Cottonwood Road. Phipps will correspond with her to get the issues resolved.

There being no further business to come before the Board the meeting was adjourned at 1:30 p.m. The Sioux County Board of Commissioners will meet February 1, 2022.

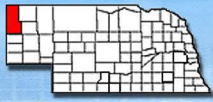

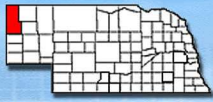
The Pledge of allegiance was recited, Josh Skavdahl led the meeting in prayer.

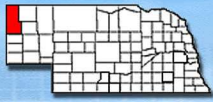

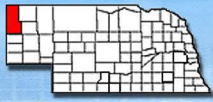
Lacy Klein, Sioux County Treasurer updated the county financial status to the board.

Jenny Nixon updated the board. The first shooting sports meet was held here at the high school this past week, with 52-53 kids participating. The robotics team competed at the regional competition. They received a teamwork award. Nebraska Extension is hosting several conferences and meetings in the coming weeks. Discussion was held on the Sandhill Center for Hope located in Alliance.

Nick Sanderson reported that he is transferring his spray rig into the other pickup. He will try the de-icer on Monroe Canyon Road. There may be some state money available for spraying.

Sheriff McCumbers updated the board stating that his new pickup has been delayed. It should be here mid-March. Two sets of body armor have been ordered. Discussions regarding communications are still ongoing with Dawes County. McCumbers is working on a policy manual, within that, cleaning and disposal of garbage will be their responsibility, for security purposes. McCumbers would like to use ARPA funding for laptops in sheriff vehicles.

Deputy County Attorney Skavdahl met with the board. Commissioner Skavdahl requested the county attorney's office look at the comprehensive plan to change the language allowing the county to deny conservation easements. Review of the current employee handbook was also discussed. Skavdahl discussed proposed changes to the wind regulations. The company requesting the changes needs to meet with the planning commission and county board in person, Attorney Skavdahl will advise them of that.
